# Students will not be permitted to attend school until all documents have been received and processed.

Final enrollment for ALL STUDENTS into a WEOC program is complete once all of the following documents have been provided:

- Original birth certificate with seal or valid passport (demonstrating parentage of custodial parent) [BTH]
- Probate court guardianship papers (for legal guardians, demonstrating relationship to student) [GDN] if applicable
- Immunization records (up to date) or District approved waiver- Provided by a doctor or health department, including proof of Varicella (Chickenpox) [VCN]
- Transcripts Current transcript [TRN] (Final transcript at the end of the current school year must be submitted)
- Parent/Guardian's Valid Driver's License or State ID- Showing photo of parent/guardian name and current address) [SID]
- **Proof of Legal Residency Documentation and Verification** These documents are outlined in the table below. **[R-doc code below]**
